
# BREAKING DOWN THE GENDER WAGE GAP

## Women earn less than men.

Over the years, the **wage gap** has gotten smaller.

Many factors contribute to the gender



### More education is often associated with higher earnings. Historically, women had lower levels of college education than men, which could

have contributed to the overall wage gap. However, in recent decades women have outpaced men in educational attainment: between 1975 and 2015, the share of women in the labor force age 25+ with a college degree increased from 14% to 41%. Over those 40 years, women went from graduating college at a much lower rate than men to actually exceeding their rate.



### to earn less than their male counterparts. Even as women have accessed more jobs in higher-paying sectors, they are still under-

work in lower-paying jobs than men are, and they remain underrepresented in many

occupations. Moreover, even when they work in the same occupations, many women continue

This is not an exhaustive list, and some causes for the wage gap remain unexplained by existing research. For example, gender discrimination may be responsible for some portion of the unexplained wage gap. However, these are some of the major factors that have been barriers to women's earning potential and pay

equality. And there is more to the story: women of color continue to face significant racial wage gaps on top of the gender wage gap.\* To ensure the health of our economy and the economic security of our nation's families,

we must do more to eliminate the gender wage gap.
